Enacted Budget Bill	SUNY Hospital State Subsidy Provides \$87.6 million for the SUNY teaching hospitals. This appropriation is \$18.5 million more than the Executive Budget's proposal for this subsidy.	Support	Passed; Signed Chapter 50 of 2015
Budget Bill	Health Care Delivery Systems Pilot Program The Executive Budget included language to develop a pilot program to restructure health care delivery systems by allowing for private capital investment. It proposed the establishment of up to five business corporations, one of which would have to affiliate with an academic medical institution or teaching hospital.	Oppose If enacted, this proposal would have opened the door for the privatization of SUNY's hospitals. Enacted Budget Bill	SUNY Investment and Performance Fund Provides \$18 million in performance-based funding. S.281-A LaValle/ A.5370-A Glick	Maintenance of Effort (MOE) Provides that the state will appropriate and make available state support to cover all mandatory costs of SUNY and SUNY's health science centers, which includes, but is not limited to, collective bargaining costs including salary increments, fringe benefits, and other non-personal service costs such as utility costs, building rentals and other inflationary expenses incurred by the SUNY and the SUNY health science centers. This bill will make the MOE permanent and disconnect it from Tuition Increase bill Chapter 260 of 2011.	Support UUP, with NYSUT and its other affiliates, advocated for the passage of this bill. UUP made this issue the center of all advocacy discussions. A genuine MOE must be established to protect funding for student services and ensure a financially secure public higher education system. A.8244 Glick/ S.5965 LaValle	Campus Sexual Assault and Violence Requires all colleges and universities in the State of New York to implement uniform prevention and response policies and procedures relating to sexual assault, domestic violence, dating violence, and stalking. One section of this bill requires institutions to annually report aggregate data and information about reports of domestic violence, dating violence, stalking, or sexual assault. This shall include the total number of reports received, open and closed investigations, outcomes of such investigations, and penalties imposed on perpetrators. In addition, this bill provides a \$1 million appropriation for college campuses to support training and other expenses related to this legislation.	Support During UUP's Spring 2014 Delegate Assembly more than 300 UUP delegates adopted a resolution addressing sexual assault on campuses. S.278 LaValle	SUNY Hospital Firewall bill Creates a firewall between the individual accounts of the SUNY hospital systems. Specifies that the funds in each hospital's accounts are for the operations of that facility alone and may not be supplemented by funds contained within any other SUNY accounts. Outstanding Issues

- **Endowment** Gained additional traction this year. This issue was considered by the Executive during budget. UUP, with NYSUT, will continue advocacy efforts for the creation of a public higher education quality initiative endowment fund.
- **DREAM Act** Passed the Assembly, UUP will continue its coalition advocacy efforts for this issue.
- **FOIL Bill** (foundation disclosure) Through UUP advocacy this issue is starting to resonate with the Legislature. For the first time, UUP saw significant movement in the Assembly committees on this bill. The Senate has shown movement on this bill in the past. UUP will continue its advocacy efforts on this bill.
- **Financial Disclosure of SUNY Campus Foundation Employees** UUP will continue to advocate for foundation transparency and will continue to pursue it through this and other similar bills.
- VOTE-COPE via Pension Deduction A relatively new bill that UUP will continue to advocate for its enactment.
- Maximum Allowable Public Service Earnings for State Retirees Passed the Senate, UUP will continue its advocacy efforts
 for this issue.
- Healthy Workforce Bill UUP will continue to advocate for this issue.
- New York State Fair Pay Act Passed the Assembly, UUP will continue to advocate for this issue.
- **Teacher Preparation Program** UUP was able to mitigate the worst of the Executive Budget proposal. For example, the governor's proposal to tie teacher preparation program deregistration and closure to test scores was limited to graduate programs. Undergraduate programs were spared. It was through UUP's intense lobbying efforts with the State Education Department (SED) and Board of Regents that safety nets for the three new certification exams and the edTPA were secured. UUP will continue its efforts to ensure that the outstanding substantive issues related to these exams and assessment are addressed by SED. UUP is pressing for a full investigation of the problems with the four SED teacher certification exams.
