UUP Academics Workload Survey—Bill Tusang, UUP Chapter President and Christina Trees, UUP VP Academics

A new survey was constructed by UUP Academics to gather information on the impact of the COVID-19 pandemic on workload, working conditions, and other aspects of Academics' professional lives and work-life balance. The survey is intended for *all* UUP Academics, both part-time and full-time, contingent and non-contingent. It if fairly long and takes 20-30 minutes to complete, depending on the level of detail you choose to pro-

vide. The intent is for our chapter to use the survey to increase awareness and educate ourselves about ways to address workload problems, identify pressing issues that need attention, and develop initiatives for campus level change. While summary results may be shared with the campus administration through UUP's Labor-Management discussions, individual responses will be viewed by UUP only.

Virtual Student Debt Clinics from 5:00 PM – 6:30 PM via - March dates

Over 12 million people in the United States are struggling to make their monthly student loan payments, and millions more see economic and personal opportunities pass as they prioritize paying down their debt. Does this sound like you or someone you know?

Many of these people may qualify for free federal programs that can help reduce their monthly payments and eventually lead to student loan forgiveness, but these lifeline programs are significantly underenrolled. In an effort to help our members get access to these programs, United University Professions and the American Federation of Teachers are proud to host a Student Debt Clinic which will provide information on how to enroll in Income-Driven Repayment plans and Public Service Loan Forgiveness.

Registration is first come, first serve, and we must cap attendance for a single clinic at 75 participants in order to ensure that we are able to provide maximum assistance to attendees. Registration will close 48 hours prior to the virtual clinic. Webinar login information will be provided prior to the clinic to all who register. [If you can't make one of these clinics, don't worry - we're planning on offering them every payday. If you want to help host a clinic at your worksite, please let us know!
