## Raise Our Voices Now Before the April 1st NYS Budget Deadline

*(continued)*

After a month of virtual advocacy meetings, the New York State Senate and Assembly house bills address the TAP GAP and include new revenue raisers of \$7-8 billion dollars. This is good news and a tribute to the advocacy work we and our allies have done so far!

But we're not over the finish line yet as there are powerful interests pressing legislators to roll back on this new revenue. We can't let this happen and must re-double our advocacy efforts before the April 1st budget deadline. Specifically, there are three key issues we need to stress with Albany lawmakers:

- We must urge legislators to keep these measures in the final NYS budget during the final days of budget negotiations with the Executive Branch and the Division of Budget;
- The Senate one house bill contains \$40 million dollars designated for hazard pay for our frontline health care workers in our public SUNY hospitals. The Assembly bill does not contain this funding, so we must contact our State Assembly-members and tell them to include hazard pay in the final NYS budget; and

- The Senate budget bill also proposes that the state pay the debt service for the three SUNY hospitals and the Assembly version does not. So, we need to tell our State Assembly-members to see that this language is included in the final budget bills due April 1st.

### UUP Academics Work- load Survey

A new survey was constructed by UUP Academics to gather information on the impact of the COVID-19 pandemic on workload, working conditions, and other aspects of Academics' professional lives and work-life balance.

The survey is intended for **all** UUP Academics, both part-time and full-time, contingent and non-contingent. It is fairly long and takes 20-30 minutes to complete, depending on the level of detail you choose to provide.

The intent is for our chapter to use the survey to increase awareness and educate ourselves about ways to address workload problems, identify pressing issues that need attention, and develop initiatives for campus level change.

While summary results may be shared with the campus administration through UUP's Labor-Management discussions, individual responses will be viewed by UUP only.

You may respond anonymously or enter your contact information at the end of the survey.

# March is Women's History Month

The Library of Congress, National Archives and Records Administration, National Endowment for the Humanities, National Gallery of Art, National Park Service, Smithsonian Institution and United States Holocaust Memorial Museum join in commemorating and encouraging the study, observance and celebration of the vital role of women in American history.

## About Women's History Month

Women's History Month had its origins as a national celebration in 1981 when Congress passed Pub. L. 97-28 which authorized and requested the President to proclaim the week beginning March 7, 1982 as "Women's History Week." Throughout the next five years, Congress continued to pass joint resolutions designating a week in March as "Women's History Week." In 1987 after being petitioned by the National Women's History Project, Congress passed Pub. L. 100-9 which designated the month of March 1987 as "Women's History Month." Between 1988 and 1994, Congress passed additional resolutions requesting and authorizing the President to proclaim March of each year as Women's History Month. Since 1995, presidents have issued a series of annual proclamations designating the month of March as "Women's History Month." These proclamations celebrate the contributions women have made to the United States and recognize the specific achievements women have made over the course of American history in a variety of fields.

## **Salary Compression Intake Deadline Extended**

Dear UUP members,

I encourage you to use the UUP Intake Form at the link below to provide us with information or voice any questions or concerns you have about the 2020 salary compression adjustments called for in the 2016-22 NYS-UUP Contract. As a result of member requests, we are extending the deadline for submitting forms to **May 1, 2021** which is May Day – International Workers Day. We hope this will better enable you to send your questions and comments to us.

These adjustments constitute the second of four years of compression adjustments required by the contract. This intake form is not to be used in lieu of contacting campus Human Resources with questions you may have about your specific circumstances. We are encouraging members who have such questions to contact HR. However, even if you speak to HR about your specific case, it is also important for UUP to know what members' questions and concerns are.

Information collected through this process will be viewed at the chapter and state levels of UUP. We will use it to address concerns that need immediate attention. We also will use this information to inform the next round of discussions

with the State over possible refinements or adjustments to the 2021 salary compression analysis. Modifications to the process and methodology adopted in the second round were a direct result of the information members provided after the first round of salary compression adjustments.

I encourage you to communicate with us through this intake form as soon as possible. We will begin analyzing all information as it comes in.

The CLEFR Program assists employees with the cost of attaining initial certifications, licenses or designations which are related to their profession or necessary for promotional opportunities and career mobility within the State University of New York (SUNY). Examination fees to renew certifications, licenses, or designations previously obtained by an employee are not reimbursable. Maximum reimbursement is \$1,000 for the period January 1, 2021 to December 31, 2021.
